Good evening everyone, what a day it has been? 2 court houses, 200 miles apart providing a remarkable split screen moment as 2 men who once thought **prominently** in president Trump's orbit crashed to earth almost **simultaneously**, tonight convicted **felons**. while here in New York, Donald Trump's former private lawyer Michael Cohen accepted his own fate in a deal with prosecutors, pleading guilty to serious crimes including paying **hush** money to Stormy Daniels to keep her quiet before the election. And Cohen says it was at the direction of then candidate Trump. Just about the same time, Cohen was admitting his guilt in New York, a Virginia jury delivered guilty verdicts on 8 tax and bank fraud charges against the president's former campaign chair Paul Manafort. Pete Williams is at the court house tonight.

The jury found Paul Manafort guilty of intentionally **dodging** taxes on millions of dollars that he earned as a political consultant for the former president of Ukraine, well before Manafort served briefly as president Trump's campaign chairman. Prosecutors said he **stashed** the money in overseas banks and used it to **indulge** his expensive tastes, in cloths, **antiques** and cars by wiring money directly from those accounts to pay his bills **bypassing** tax collectors from IRS. From 2010 through 2014 prosecutors said Manafort earned more than 30 million dollars, but reported less than half of it as income.

When the Ukrainian money dried up, prosecutors said Manafort lied in applying for more than 20 million in loans from three banks to maintain his **lavish** spending habits. The jury convicted him of 2 of those bank fraud counts. In all, Manafort faced 18 criminal counts. The jury convicted him on 8 of them, but could not agree on the other ten. Of those, the judge declared a **mistrial** leaving the prosecutors free to charge him with them all over again, though tonight, that seems unlikely. The conviction is a **boost** for Robert Mueller. Manafort was the first person he charged after becoming **special counsel, presumably** to force Manafort's cooperation in the Russian **meddling** investigation.

Manaford;'s lawyer spoke only briefly, thanking the judge and jury for what they said, was a fair trial. "Mr. Manafort is disappointed of not getting **acquittals** all the way through or a complete **hung jury** on all counts. He is evaluating all of his options at this point." When he sentenced, he could face up to 10 years in prison and next month, Manafort goes on trial again. In federal court in Washington, he faces charges of failing to register as a lobbyist for Ukraine, **witness tampering** and financial fraud. Alright, Pete Williams in Virginia, thanks...
